QUALIFICATIONS

- A regular, verifiable source of income
- An active checking account
- A working phone

REQUIRED ITEMS

- Your most recent pay stub (if you are employed)
OR
Your most recent bank statement (if you have another source of income)
- Your checkbook
- Driver's license or government-issued photo ID

FINANCE CHARGE SCHEDULE

The APR calculation is based on a transaction with a 14-day term. Your APR may be different if your transaction term is not 14 days. The APR of your transaction will be disclosed in the federal Truth-In-Lending Statement contained in your contract. The Total of Payments represents the amount of the check you will write to us. If the Total of Payments exceeds \$300, then you may be required to write us more than one check. If your bank dishonors the check, then you must pay us a returned check fee of \$25.
